What personal data do we collect from you?

Your name, address, telephone number and e-mail address.

Why do we collect this personal data from you?

To contact you after you have filled in our contact form.

How long do we retain your personal data?

How do we ensure the security of your data?

What are the rights you can exercise?

Via this link you can leave your e-mail address, with which you have already entered information on the website. You will then receive an e-mail with a

link to view your data. This allows you to modify or completely delete your data. Your request will then be processed by Medditation to ensure the exercise of your rights. And these will be removed from the back of the website, if you prefer.
